OFF-PAYROLL WORKING (KNOWN AS IR35)

IR35 legislation introduced in April 2021 requires us to check whether the way in which a contractor/supplier provides their services to a client falls within these regulations. It places an obligation on the contractor/supplier to facilitate this check by providing the following information.

Statement 1:

I personally provide my service, either directly or indirectly, through my Personal Service Company ("PSC").

Important note – for the purposes of IR35 regulations, you provide your service through a PSC if one of the following conditions are met:

- a) Your business is a Ltd Company & you or your spouse own 5% or more of the ordinary share capital of the Limited Company.
- b) Your business is a Limited Liability Partnership (LLP) and either:
 - You and your relatives are entitled to receive 60% or more of the total profits of the Partnership.
 - Most of the profits derive from the provision of services under engagements to a single client.
 - Under profit sharing arrangements, the income of any of the partners is based on the amount of income generated by that partner by the provision of services under engagements which are caught by IR35.

Statement 2:

I provide the service myself as a genuinely self-employed, independent contractor/worker who is registered as such with HMRC. I do not provide my service personally, directly, or indirectly, through a PSC as defined in Statement 1.

Statement 3:

My company is a 'contracted out service provider', contracted to provide a service. My company decides which workers are to be used in the supply of that service. I do not provide my service personally, directly, or indirectly, through a PSC as defined in Statement 1.

I authorise Event to pass this information to Event's Clients for the purposes of compliance with the IR35 Regulations.
